### TERMS AND CONDITIONS FOR SUPPLY OF EQUIPMENTS

1. The Royal Securities Exchange of Bhutan (RSEB) will not provide import license. The supplier has to provide a copy of trade license also along with the Tender.
2. Rates quoted in the tender should be in Ngultrum, including withholding taxes and other taxes in Bhutan and CIF.
3. The rate quoted shall be valid for the period of 60 days from the date of the tender opening.
4. The supplier should be responsible for necessary checking and installation of the equipments.
5. Earnest money of Nu. 10,000/- is required in the form of Cash warrant in favour of RSEB payable at Thimphu only along with the tender. (refundable/adjustable against Security Deposit)
6. The supplies shall be completed within one month (30 days) from the date of receiving the supply order. For delay the beyond the stipulated time penalty shall be imposed @ 1% of the supply amount per week limited to a maximum of 10%.
7. The equipment supplied should be of full set in original as per specification along with all necessary user manuals at the time of supply.
8. The work shall be awarded on technical evaluation of the bid. The lowest bid shall be awarded the work.
9. The RSEB will not provide any advance payments for the supply of the equipments/material.
10. The RSEB has right to inspect, test and, if not satisfied, reject the goods supplied and the supplier shall replace the goods at no additional cost to the RSEB.
11. Earnest money of Nu. 10,000/- will be retained as security deposit till the end of warranty period. ( to be specify by the supplier)

12. Tenders should be submitted as per the specification mentioned in attached format by the bidder, which should be signed by authorize signatures.
13. The RSEB reserves the right to vary the quantity on same terms and conditions.
14. No modification or changes in the rate shall be entertained after the tender is opened.
15. The last day and the time of the submission is 6<sup>th</sup> May 2022 at 12 Noon at the **RSEB office premises**, Thimphu and will opened on the **same day at 2.30PM**.
16. If the selected bidder fails to supply the full quantity within the stipulated time the security deposit will be forfeited / invoked and the purchaser shall recover from the supplier liquidated damages being the difference in cost between the contract price and the price paid by the purchaser for the quantity not supplied and purchased from other parties.
17. The supplier registered / licensed in Bhutan required to produce copy of latest income Tax Clearance Certificates from the RRCO, Thimphu. The other suppliers have to produce Income TAX registration / PAN documents copy, along with the tender.
18. The bidder must confirm that all the goods shall carry the nominal international warranty accorded by the respective manufacturers and the bidder shall accept to fulfill all claims free of cost within the warranty period. ( warranty period must be clearly specified in the Tender).
19. The tender shall be cancelled in case the laptops are found to be assembled locally.
20. Tenders which do not comply with the terms and conditions outlined above will not be evaluate and summarily rejected.
21. The RSEB's decision will be final and binding in case of any dispute.
